


Land that has been cropped four out of the six years between 1996 to 2001

- Environmentally sound solution to improve snow management
- Serve as visual clues and/or landmarks to help drivers find their way
- Provide wildlife habitat
- Control soil erosion and reduce springtime flooding
- Improve water quality
- Sequester carbon to reduce atmospheric carbon dioxide
- Increase crop yields by 10 percent or more
- Decrease home heating costs when placed around the farmstead
